The Board of Directors of Fluidra S.A. (the "**Company**") issues this document to report on the proposal of Mr. Jorge Valentín Constans Fernández to be appointed as directorto fill the vacancy arisen in the Board, taking into account the provisions of the Bylaws and the Board of Directors regulations, the system contemplated in the Restated Corporate Enterprises Law and the principles of the Code of Good Governance for listed companies.
