Fluidra, S.A. ("**Fluidra**" or the "**Company**"), pursuant to the provisions of section 227 of Royal Legislative Decree 4/2015, of 23 October, which passed the amended text of the Securities Market Act, hereby issues the following:

RELEVANT INFORMATION

Fluidra is launching a refinancing process seeking to reprice the existing tranches of its Credit and Guaranty Agreement dated as of 2 July 2018 and initially granted for a total amount of Euro 980 million.

In particular, the Company will perform a partial prepayment amounting to Euro 150 million of the existing term loan facilities using available cash on balance sheet and, in conjunction with such prepayment, is seeking to reprice (i) its existing Euro and USD term loans' interest rates and (ii) its existing revolving commitments' interest rate.
